A WARM WELCOME TO THE CONFERENCE FROM THE SCIENTIFIC COMMITEE

Hello to all and a very warm welcome from us. This is our fourth international Trauma Informed Care in Practice conference and our 9th event exploring different aspects of trauma. We are delighted to be collaborating with the Crisis, Disaster and Trauma Section of the British Psychological Society to bring you this event.

This years conference is focused on exploring the intersection between personality disorder and complex trauma. The relationship between trauma and personality needs is a critical debate with very real consequences for individuals and teams.

We have developed a conference programme that explores this complex relationship as well as stressing the importance of moving beyond these discussions and focusing on meeting the needs of individuals. Whilst it is important to acknowledge the complexities of language and diagnoses, it is also important that we ensure we have effective assessments, treatments and services that can support trauma-exposed populations, including those whose primary needs are not identified as being trauma-focused.

The conference brings together presentations across four key areas (symposiums). The first explores the evidence relating to the nature of the relationship between personality disorder and trauma diagnoses. This symposia contains three oral papers and a panel discussion.

The second symposium moves beyond diagnoses and focuses on supporting common needs found in individuals who have personality or trauma-related needs.

The third symposium explores treatment approaches that are relevant to people with personality and trauma-related needs.

The final brief symposia explores the wellbeing needs of staff working in this intersection, including systemic preventative and management support solutions.

We also have a series of brief poster presentations delivered by practitioners and researchers in the trauma field that provide evaluations and evidence of current practice in the UK.

We hope you play an active role in the day and stimulate much needed discussions in this area of practice.



Opening Comments: Dr Sanjith Kamath Executive Medical Director, St Andrew's Healthcare, UK



Dr Sanjith Kamath has been a Consultant Psychiatrist since 2007, working in both the NHS and the private sector before joining St Andrew's to work in the Women's Service in 2012 where he subsequently became Clinical Director.

As a general adult psychiatrist, Dr Kamath runs a weekly outpatient clinic at St Andrew's and has a wide range of expertise in the assessment and management of individuals with difficulties including depression and anxiety disorders, stress-related disorders including Post-Traumatic Stress Disorder (PTSD), alcohol and drug problems, bipolar disorder, psychosis and schizophrenia, and obsessive compulsive disorder (OCD).

Dr Kamath has worked in private practice since 2009 and has extensive experience working with people across inpatient, medico-legal and outpatient settings. He has provided psychiatric assessment reports on the instructions of occupational health physicians for different bodies including the police and fire services.

He was recently invited to lecture at the Spring Conference of the ALAMA (Association of Local Authority Medical Advisors) to doctors providing occupational health services to local authority employees and employers such as the police, fire and the National Health Service.

Dr Anne Krause-Utz, Assistant Professor, Leiden University, Netherlands

Annegret Krause-Utz obtained her Diploma in Psychology at Mannheim University (Germany) in 2007. Afterwards, she did her training in (dialectical) behavioral therapy and worked as a (post)doctoral researcher at the Central Institute of Mental Health (Psychosomatic Medicine and Psychotherapy) in Mannheim. In February 2014, she obtained her PhD degree at the Medical Faculty of Heidelberg University and became head of the Research Group 'Stress and Cognition' at the Central Institute.



In 2017, she completed an extra PhD program at Leiden University. Currently, she works as an Assistant Professor in Clinical Psychology and teaches various clinical courses. She has been specialized in working with patients with trauma-related disorders, dissociative disorders, and personality disorders and currently works as a DBT therapist in private practice. Currently Anne is section editor for the Borderline Personality Disorder and Emotion Dysregulation Journal.



Dr Emily Fox, Director of Psychological Therapies, St Andrew's Healthcare & Chair, Society for DBT UK

Dr. Emily Fox has been a Consultant Clinical Psychologist since 2004. Since qualifying, Emily has worked in a number of inpatient settings including learning disability, eating disorders, acute admissions, and adolescents. Since 2003 she has worked in women's inpatient units delivering a comprehensive DBT programme. Emily completed her DBT Intensive Training in 2004 in Northampton, USA. From 2015-2017 she was Head of Psychology for the Charity, and appointed as Director of Psychological Therapies in 2020.

In 2009 Emily undertook DBT supervision with Heidi Heard, PhD, and joined the British Isles DBT Training team in 2010. In 2012, Emily was nominated as General Secretary for the Society for DBT (SfDBT) for the UK and Ireland. Since 2016 she has been Chair for the SfDBT for the UK and Ireland.

Emily has co-authored many papers regarding the delivery of DBT in inpatient settings and more recently focused on diagnostic differences between Personality Disorder (Borderline Pattern Specifiers) and Complex Post-traumatic Stress Disorder. Further, she authored the chapter 'Delivering DBT in an Inpatient Setting' in The Oxford Handbook of Dialectical Behaviour Therapy edited by Michaela Swales and published by OUP in 2018.

Professor Benjamin Johnson, Assistant Professor, Fairleigh Dickinson University, USA

Professor Johnson received his B.A. from Emory University in 2012 with a double major in Psychology and English. Afterwards, he spent two years as a Research Coordinator in the Emory Child and Adolescent Mood Program working with adolescents and young adults with symptoms of borderline personality disorder (BPD). He later received his PhD from Penn State University and is currently working as an assistant professor at Fairleigh Dickinson University in Teaneck, New Jersey.



He studies personality disorders, focused on improving assessment of non-suicidal self-harm, suicide, and other behaviors often linked to personality disorders. He is also interested in the role of trauma in the development of personality disorders as well as in the similarities and differences between chronic physical pain and mental pain and the role of self-harm in pain and emotion regulation.

CONFERENCE PROGRAMME: SYMPOSIA 3 & 4



Professor Nikolaus Kleindienst, Central Institute of Mental Health, Germany

Professor Kleindienst's research at the Central Institute of Mental Health (CIMH) aims at expanding effective treatment options for trauma-associated disorders. At the CIMH he oversees and works with a team of researchers and clinicians to develop new psychotherapeutic approaches that are based on recent advances in neurobiological and psychological evidence.

During the last few years, his research group has been developing DBT-PTSD, a new form of psychotherapy.

Since 2020, Nikolaus has authored or co-authored 37 peer-reviewed articles, including publications in high-ranking journals in both psychiatry (e.g., JAMA Psychiatry) and clinical psychology (e.g., Journal of Consulting and Clinical Psychology)


