Executive Summary

Once again, the CDCT has had a productive year and continues to make a significant impact on the lives of those impacted by psychosocial trauma and the organisation of which it is a part. We continue to see a significant rate of high-quality publications with over 103 peer reviewed papers, conference papers or book chapters published, to date, and increasing attendances at the three international conferences held this year. It is great to see the continued national and international reach of the CDCT as the team works in collaboration with 27 researchers and clinicians outside of the Charity. I am particularly proud of the high standard of teaching provided by the CDCT as evidenced by the satisfaction rates of our MSc students which are always excellent for every aspect of their course. Whilst the academic record is impressive, it is the practical application of the CDCT is doing into supporting the trauma needs of Deaf people is outstanding and makes me extremely proud of the whole team and their collaborators. The CDCT has successfully met its ambitious KPI targets for 2024-2025. We have also achieved a number of key milestones. Notably, we have achieved our 100th publication, supported over 60 clinicians in the Charity to publish with us and over 3800 people have attended our international conferences, to date. We have, for the first time, experienced small steps in our goal to influence national policy innovations and practice guidance. Our work with the St Andrew's Deaf service and SIGN Health has led to new developments in BSL and national practice guidance for working with Deaf trauma populations. Through our work with the British Psychological Society we are co-authoring updated professional guidance relating to the training standards for practitioner psychologists working in trauma populations. Our work in moral injury and occupational distress continues to gain international attention, with notable publications and consultation work this year. 2024-205 also saw the successful launch of the the Annual Recognition Awards for psychological trauma, attracting strong national and international submissions that will support taking research and clinical practice forward.

Our special interest and practice development groups continue to evolve and support clinicians working in complex areas of practice to network, globally. Our growing reputation in the field has contributed to securing edited book agreements for three publications with Routledge Press for the coming year and consultation and supervision contracts. In a busy year we have been particularly mindful of balancing the investment between foundational and growth activities; ensuring we pursue sustainable growth that aligns with our core values. Nurturing and supporting our small and gifted team continues to be a source of personal and professional pride. I am especially grateful for the support of Katie Fell and Dr Elanor Henry-Webb in the production of this report. Their creativity, commitment to, and pride in, sharing the work of the CDCT demonstrates the depth of talent and professionalism in our team.






The Centre for Developmental and Complex Trauma (CDCT), part of St Andrew's Healthcare, was established in 2021. The centre is driven by the core goal of improving outcomes for people with pervasive and complex trauma histories, and who face particular marginalisation within society.



Performance by numbers

Building on our previous ambitious annual KPI targets, the CDCT has demonstrated growth in its core activities and performance across 2024-2025.

Quality, Satisfaction and Reputation

The introduction of satisfaction ratings as a new KPI for 2024-2025 has been significant. Notably, across conference and higher education domains, individuals receiving services from the CDCT reported high levels of satisfaction, contributing to the centre's growing reputation.


High levels of engagement on social media platforms from healthcare professionals and academics exceeded KPI targets, with all areas of CDCT activities showing high levels of engagement. Notably, initiatives related to autistic, Deaf, and staff groups garnered particularly high engagement and support through social media and accessing our academic work through ResearchGate.

Growth

The current year also produced significant areas of growth. An additional postgraduate course was validated (PGDiP) and the MSc in Psychological Trauma had its second intake.

Two additional Special Interest Groups were launched, attracting strong international membership, reflecting an overall growth of CDCT membership.

Reputation & influence

The fourth year of the CDCT has been crucial in developing its reputation and influence in the field of traumatology. We have made positive progress in academic domains though publishing in a globally ranked journal, securing a number of edited book contracts and guest editing a highly successful volume in a peer reviewed journal. With have also made progress in supporting and raising the profile of underserved populations through the development of national guidance for clinical, research and health policy development for Deaf people, and working with key stakeholders to develop new trauma focused signs for British Sign Language.

Guest Journal Editor Emerald Publishing

Building on our ongoing partnership with Emerald Publishing, the CDCT edited and contributed a research paper for a special edition volume of the 'Advances in Autism' journal that addressed the trauma needs of autistic individuals. This special edition has been highly rated by readers, social media and Emerald

- Over 5000 downloads of the special edition in 5 months making it the most downloaded volume for the year and for 2023.
- Free webinar for the special edition was attended by over 500 people and received high levels of engagement in social media



Edited Book contracts with leading publisher

The increasing recognition of our research skills has led to securing three edited book contracts with Routledge Press. These publications, which align with the core mission of the CDCT are scheduled for release—two in 2025 and two in early 2026. Notably, Dr. Jon Taylor, Consultant Forensic Psychologist, has secured a two-book deal that showcases his expertise and international reputation in compassion-based approaches.



Developing Trauma practice with Deaf people

Our research collaborations with the Deaf Service at St Andrew's and our joint work in collaboration with SIGN Health has been impactful in influencing national practice guidance in working with Deaf people with trauma needs, and has led to the development of new trauma focused signs in British Sign Language.



Publishing in Globally ranked Journal

This year, a major focus has been on enhancing the reach and quality of our research disseminations. As a part of an international collaboration, the CDCT has published in the prestigious globally ranked New England Journal of Medicine.



This year saw the continued success of the MSc Practitioner in Psychological Trauma course, delivered in partnership with the Faculty of Medicine and Health Sciences, University of Buckingham.

July marked the successful completion of the first year of the course for the 'maiden' cohort, whilst September saw the launch of the second intake for the course.

The second running year brought the successful recruitment of a larger cohort of students representing several healthcare professions, namely social work, psychology and nursing. Anonymous student feedback continues to be exceptionally high, with aggregated scores for all modules in the 'excellent' range The 'extremely good quality' of feedback provided to students by the course team for assessment activities and the robustness of marking processes was noted by the external examiner at the

examination board for the MSc in January 2025.

Building on the success of this first course, this year also saw the expansion of the higher education portfolio, with marketing of the new Postgraduate Diploma in Complex Trauma course officially launched for a September 2025 intake.

The continued development of the postgraduate portfolio will be a key focus and goal for the CDCT over the forthcoming year.






This year, the CDCT celebrated reaching its **100th publication**, a milestone achieved through establishing and nurturing internal and external partnerships to build on a collaborative portfolio of projects addressing service user, staff and organisational needs.

The CDCT has continued to achieve its KPI publishing target for 2024-2025, submitting 10 peer-reviewed journal articles to outlets with an impact factor of 1+, spanning each of the research streams established.

The CDCT has also continued to establish its reputation, foster partnerships and disseminate critical findings from its research and service development portfolio through presentation of papers and posters at key national and international conferencing events.

Key achievements for the 2024-25 year are summarised below. The distribution of submissions across research streams is also illustrated, reflecting the Centre's focus on several marginalised populations and breadth of expertise.





In the last year over 900 people attended CDCT conference events, with over 3000 people attending events attending since the conference programme started in November 2020. Our key partnerships with the CDT section of the BPS and the Moral Injury of Healthcare have continued, leading to impactful events

This year, a new conference collaboration with Emerald Publishing, to promote the special edition of the journal guest edited by Dr Deborah Morris, was launched. The event attracted a significant audience, with over 500 people signing up to attend, and generates high levels of positive delegate feedback.

Building on the successful delivery of its existing portfolio of Special Interest Groups (SIGs) in the previous year, the CDCT has continued to expand its portfolio of SIGs.


This year saw the establishment of a new SIG, focused on bringing the trauma needs of deaf people into the spotlight. This has been a collaborative enterprise between the CDCT, the Deaf Service in St Andrew's Healthcare, and Deaf health charity 'SignHealth', and has fostered new ways of working to ensure the delivery of a group that is most accessible and relevant to the needs and interests of Deaf people.

The centre's existing 'Moral Injury' and 'Trauma and Personality Needs' SIGs have also continued to prosper, attracting new membership, fostering networking opportunities with key stakeholders, and facilitating the dissemination of the latest advances in research, policy and practice.

The SIGs continue to attract an international audience, with members across the three groups from 14 countries. This is inclusive of all regions of the United Kingdom and Ireland, North America, Canada, Germany, the Netherlands, Norway, Denmark, China, Australia and New Zealand.

Members of the SIGs include clinical practitioners, professionals across wider sectors, academics and researchers, students, and people with lived experience.

Over the forthcoming year, the CDCT will continue to foster the SIG portfolio, to ensure the continued communication of latest knowledge and research, and its subsequent translation into policy and practice.

2024 saw the launch of the First Annual Recognition Awards in psychological trauma. The aim of the awards is to ensure the strong visibility of well-designed, evidence-based research and clinical innovations in the field, and to ensure that research and evidence bases continue to drive the development of clinical services to improve the wellbeing and outcomes of different trauma populations.

The awards, led by the CDCT are offered in collaboration with key leading organizations in the UK and, overseen by senior clinicians, academics and strategy leaders in the field of traumatology. The first year of the awards attracted submissions from across the UK, including NHS and independent providers and submissions from the USA and Australia.

Winners of the awards have demonstrated high levels of engagement with ARA team, utilising the support elements offered with the awards. Of note is that award winners have reported the very positive responses from their own organisations, with NHS promoting their winning submissions through social media. The anticipated positive effects on future grant applications to fund research and innovation have also been noted by winners.


