

#### Year in review: Our team, our new home

The CDCT moved into the new Foster Postgraduate Centre (FPC) in April 2023, following extensive re-development, to create an exceptional learning space. The refurbishment was funded by St Andrew's Healthcare, with the design and development of the FPC overseen by the Estates and Facilities Department, STAH and the CDCT.

The FPC functions as a dedicated higher education environment and hosts the facilities that students would expect of a university campus.

Facilities in the FPC include:

- Two IT-equipped lecture rooms
- · Six seminar, meeting and study rooms
- · Library and computer facilities
- Student lounge area
- · Kitchen & eating area
- · Therapy observation training suite
- · Placement student offices
- Staff offices
- · Toilets, including an accessible toilet

The move to the FPC was key to the expansion of the postgraduate and CPD programmes developed by the CDCT.



Year in review: Key Performance Indicators (KPIs) - The numbers.....

The CDCT was set ambitious annual KPI targets reflecting the overall remit of the CDCT - to advance the needs of marginalised communities impacted by trauma, and to develop skilled staff groups.

KPIs for 2023-2024 related to research and service development activities, disseminating findings enhancing the knowledge of staff groups through educational and conferencing activities, to reduce the gap between research and clinical practice. All KPIs were either met or exceeded for the year.



#### **Disseminations**

In the current review period, 10 papers were accepted and presented at conferences across the UK. Ten manuscripts have also been submitted to peer-reviewed journals.



#### **CPD Activities**

The CDCT exceeded its target of hosting three international conferences, with a forth conference added to its programme. In addition, eight CPD events were successfully delivered and a new SIG was developed and piloted.



#### Social Media Presence

Social media engagements exceeded targets, achieving 96,025 engagements across LinkedIn and Twitter. Similarly ResearchGate reads showed a significant increase from 2022-2023, recording 4,647 reads of CDCT research papers.




#### Clinical Impact

The CDCT met it's target of supporting four services from within St Andrew's to engage in, deliver and disseminate meaningful service development initiatives.



#### Higher education

The CDCT achieved a significant milestone in launching its first postgraduate course and having a second approved by the University of Buckingham.



# Year in review: Research & service development programme

The CDCT has continued to develop a growing portfolio of clinically valuable research, exploring the needs of people detained to secure mental health services as well as those responsible for their provision of care. The CDCT has achieved its KPI targets for the 23-24 year, submitting 10 peer-reviewed journal articles across its research streams.

The dissemination of key findings to practitioners has also been achieved through the delivery of 10 conference papers and posters at national and international external events.

Conference disseminations represented five of the centres research streams, with this figure exclusive of events hosted by the CDCT. Publications reflect our core values of raising the profiles of disenfranchised populations and promoting integrity in healthcare.

Inclusive of peer reviewed journal papers, book chapters and conference presentations, the CDCT has now achieved 80 publications since its launch, first as a research stream in April 2020 and later as a Centre in April 2021.

#### COLLABORATION

During 2023-2024, the CDCT has collaborated on projects with 16 clinicians within St Andrew's Healthcare and 15 external partners. Eight partners have been in early-stage 'pre-qualified' roles.

#### **EQUALITY**

We have continued to increase the the Impact Factor (IF) of the peer reviewed journals we publish with, establishing a current median IF of 2.1 for our research publications.

#### INTERNATIONAL REACH

The CDCT is committed to maximising dissemination of its research. International reach is achieved through presentation at conferencing events across the globe, publication of research in internationally impactful journals, and collaborations with overseas partners.


#### Current CDCT research streams

# Year in review: International conference programme

The CDCT has hosted four international conferences attracting over 800 delegates, with the 4th International Trauma Informed Care conference attracting over 340 attendees. Working with 39 speakers from across the globe, an increase in international attendees from Australia, Europe, Africa, and North America was also noted.

Ongoing collaborations with the Crisis, Disaster and Trauma section of the British Psychological Society, Moral Injury of Healthcare, US and the NHS RADIANT group ensure that we develop and host impactful events, attracting world class speakers.

Additionally, a new conference focusing on the needs of adults in secure services attracted a strong NHS presence. New conferences are also planned for 2024-2025.

Quality assurance ratings from delegates across all events have consistently exceeded 90%. In addition, speakers have consistently received highly positive feedback at all events.

#### Year in review: Postgraduate programmes in trauma

The launch of the MSc 'Practitioner in Psychological Trauma', in partnership with the Faculty of Medicine and Health Sciences, University of Buckingham in September 2023, was a pivotal achievement for the CDCT.

Recruiting students from the NHS and Charity sectors, the MSc has gained positive feedback across student satisfaction and quality surveys in its first year of launching.

The MSc has also recruited for a 2024-2026 intake, with nursing psychology professionals strongly represented across both cohorts.

Following the success of the MSc, an additional course, the 'Postgraduate Diploma in Complex Trauma' has been approved for recruitment for a January 2025 intake. #### Year in review: CPD events

The past year has seen the continued delivery and expansion of the CDCT's Continuing Professional Development (CPD) programme, relating to research methodologies that translate into clinical settings. The aim of this programme is to equip clinicians with the necessary skills to develop and successfully evaluate the efficacy of clinical initiatives to ensure we are providing robust models of care.

Four workshops relating to the use of specialist research designs and advanced statistical methods have been delivered to over 30 attendees from a range of divisions and professions. Feedback for the events has been positive, with a median overall increase in confidence of +7.

To increase accessibility of these events, the coming year will see the delivery of workshops online, to compliment our current in-person programme.

#### Year in review: Special Interest Groups (SIGs)


The CDCT has expanded its portfolio of special interest groups (SIGs)over the 2023-2024 year, establishing a new SIG in 'Trauma and Personality Needs' alongside the already established 'Moral Injury' SIG that continues to grow.

The SIGs provide a platform for academics, clinicians, students and professionals working within and outside of healthcare to discuss, share and reflect on the latest advancements, challenges and ideas within the field, and to establish and develop collaborative working relationships.

Both SIGs have an established and evolving membership base, each with over fifty members. Both groups have attracted international membership, with individuals from all regions of the UK, China, Germany, Norway, Denmark, USA, Canada and Australia.

The consolidation of and increasing the impact of the SIGs reflects an ongoing focus for the coming year.

As a part of the expansion of the SIG's, we have refreshed and extended our bi-annual newsletters to include interviews with international experts, updates on the latest literature, and opportunities for potential research collaborations.





#### Year Review: Clinical Impact

The CDCT has continued to work with a range of clinical services who support marginalised populations to develop clinical frameworks, improve understanding of patient need and advance clinical practice relating to psychotraumatology. In the coming year, the CDCT will continue to support services to develop and evaluate trauma sensitive and specialist services.



#### Dialectical Behaviour Therapy Service

Building on a portfolio of work examining levels and impact of trauma symptoms in women with EUPD, the CDCT and DBT service explored how comorbid trauma presentations influence levels of observed risk and subsequent need for safety interventions.

#### **Brain Injury Screening**

The CDCT has continued to work with the MSU ABI service to pilot a tool assessing for potential traumatic brain injuries in patients. This tool is now being rolled out across non-ABI medium secure services within the organisation, for the purpose of screening for potential undetected brain injuries in patients and informing further assessment and care planning.

#### **Deaf Service**

Following from previous work establishing high rates of childhood adversity within the deaf service, we conducted a Delphi study to inform guidance for working with trauma needs in deaf populations and identify future clinical, research & social priorities. Our priority with the deaf service is to support their development of specialist trauma pathways to ensure positive outcomes for service users.

#### Trauma Response Service

The CDCT has continued to support the TRS, outlining pathways of care derived from data relating to referral patterns and areas of need. In the coming year we will continue to work with the TRS to develop care pathways that are responsive in their intensity to the presenting level of need and inclusive of sleep disturbance and complex trauma.

"Each year since 2020, the CDCT has worked with and explored data from the Trauma Response Service (TRS), which has provided useful clinical insights in developing services for staff. In the last 12 months, the focus was on the psychosocial and wellbeing needs of referred staff. Working with the CDCT enables the development of the service, and raises the profile of both the CDCT and Charity in sharing best practice on how trauma services for staff working in secure psychiatric services can be provided."

#### Year Review: Reputation, Consultation and Impact

During 2023-2024, the CDCT's growing reputation for delivering high quality work with a strong degree of academic rigour has led to increased opportunities for commissioned work and international collaborations, including co authoring books and guest editing journals.

#### **Commissioned Consultation**

This year, the CDCT, in partnership with US non-profit Moral Injury of Healthcare, successfully completed a commissioned practice guidance report for an agency within the US Department of Defence. The report and its recommendations have been accepted.





#### Guest Editor, Advances in Autism

Dr Morris has continued as a guest editor for a peer reviewed academic journal, focusing on special issues on trauma needs in marginalised populations. This summer, a special edition focusing on meeting the trauma needs of autistic adults is due to be published.

#### **Edited Book & Book Chapters**

The CDCT, in partnership with practitioner researcher partners in the UK and Australia, have been invited to edit a book for Routledge Press focusing on promoting best practice in meeting the trauma needs of marginalised populations detained in forensic services. Work on this book is under way. The CDCT have also been invited to contribute two book chapters to a second book focused on best practice guidance on trauma interventions in forensic services.






#### **Annual Recognition Awards in Trauma**

In March 2024, the CDCT launched the Annual Recognition Awards (ARAs) in trauma research and practice. The ARAs are a collaboration with the Crisis, Disaster and Trauma Section of the British Psychological Society, the RADIANT NHS research group and the Compassionate Mind Foundation. The awards are a key innovation in our goal to reduce the gap between research and clinical practice and ensure that marginalised groups equitably benefit from trauma innovations.

#### The Year Ahead: 2024-2025

In 2024-2025, the CDCT will enter its fourth year. Our core values and goals continue to drive our priorities, innovations and growth. The expanding and growing maturity of our portfolio, coupled with attracting increasing influencing collaborating partners, will provide the foundations to support further expansion of the activities of the CDCT.

In our fourth year, we will extend our influence and publish, in collaboration with our partners, our first guidance relating to clinical practice for working with a marginalised group, as well as our first organisational guidance relating to the management of occupational distress. Our conferencing and higher education provision will continue to develop, with new activities being launched for 2025. The 2024-2025 period will be a further time of consolidation and growth.
