Safeguarding Children

1. Policy Summary / Statement

Effective safeguarding arrangements seek to prevent and protect individuals from harm or abuse, regardless of their circumstances. In the UK, the foundations of safeguarding children legislation are held within the United Nations Convention on the Rights of the Child.

For the purposes of this policy, as defined within statutory guidance laid down within the Children Act (1989, 2004 and 2018) a child is defined as anyone who has not yet reached their 18th birthday. 'Children' therefore means 'children and young people' throughout.

All health organisations are required to adhere to the following arrangements and legislation,

- The Crime and Disorder Act 1998
- Female Genital Mutilation Act 2003
- Mental Capacity Act 2005 and Mental Capacity (Amendment) Act 2019
- Convention on the Rights of Persons with Disabilities 2006
- Mental Health Act 2007
- Children and Families Act 2014
- Modern Slavery Act 2015
- Serious Crime Act 2015.

Safeguarding legislation specific to children and to young people transitioning into adults, including children in care,

- United Nations Convention on the Rights of the Child 1989
- Children Act 1989, 2004 and 2018
- Promoting the Health of Looked After Children Statutory Guidance 2015
- Children and Social Work Act 2017
- Working Together to Safeguard Children Statutory Guidance 2019
- Safeguarding Children and Young People: Roles and Competencies for Healthcare Staff 2019

The Working Together to Safeguard Children 2019 statutory guidance on inter-agency working to safeguard and promote the welfare of children, defines the safeguarding and promoting the welfare of children as:

- protecting children from maltreatment
- preventing impairment of children's health or development
- ensuring that children grow up in circumstances consistent with the provision of safe

and effective care

- taking action to enable all children to have the best outcomes.

Working Together 2019 <http://www.workingtogetheronline.co.uk/> describes a co-ordinated approach making it clear what individuals, organisations and agencies must and should do to keep children safe and emphasising that effective safeguarding is achieved by putting children at the centre of the system and by every individual and agency playing their full part.

St Andrew's Healthcare is committed to providing safe and high quality care and support with safeguarding being everyone's responsibility. If children and families are to receive the right help at the right time, everyone who comes into contact with them has a role to play in identifying concerns, sharing information and taking prompt action.

All staff who come into contact with children and young people have a responsibility to safeguard and promote their welfare and should know what to do if they have concerns about safeguarding/child protection issues

This document provides a clear framework, which identifies the competencies required for all healthcare staff. Levels 1-3 relate to different occupational groups, while level 4 and 5 are related to specific roles. This version of the framework also includes specific detail for chief executives, chairs, board members including executives, non-executives and lay members.
