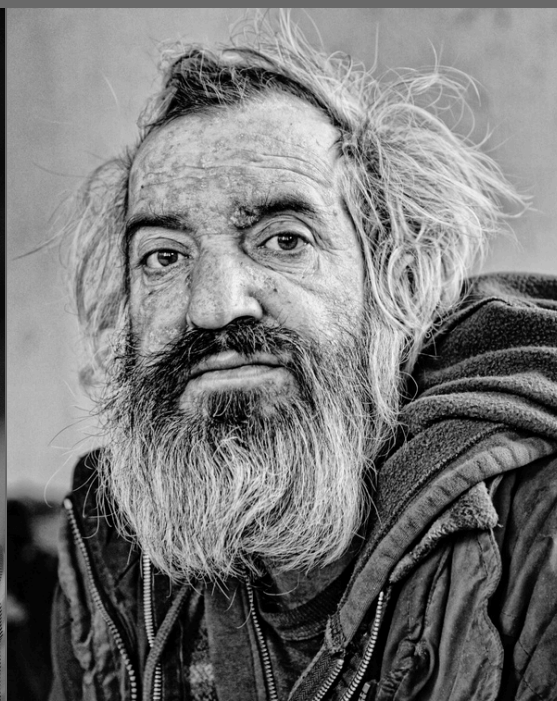

Please accept our very warm welcome to this years conference, the 6th International Trauma Informed Care online conference. This event is led by the Centre for Developmental and Complex Trauma and co-sponsored by the Crisis, Disaster and Trauma section of the British Psychological Society.

This years conference brings together a host of international speakers focusing on, “Overcoming dilemmas & challenges to maximise outcomes in complex trauma”, as well as offering a series of brief presenting papers and conference posters relating to current developments in the field.

Throughout the day we have a series of brief ‘abstract style’ presentations led by early and mid career clinicians and researchers, offering insights and guidance relating to underserved populations, novel applications of trauma informed care frameworks or new and emerging evidence. In symposium one we explore the origins of complex trauma, with expert discussions around the following topics: identity theory of CPTSD, the importance of emotional regulation and an in-depth look at integrated models for trauma formulations.

Next, in symposium two, we examine the critical factors for success in therapy. By considering presentations in the following areas: professional practical challenges and solutions and a discussion around developmental trauma perspectives for children and young people. This symposium concludes with a presentation exploring the factors affecting CPTSD treatment outcomes, with a keynote presentation relating to outcomes from the ESTAIR treatment programme.

In symposium three, we draw our focus to the needs of underserved populations, one of the CDCT’s key objectives; to increase awareness of the trauma experiences and care needs for the most marginalised sections of society. We will hear presentations on the following areas: service user perspectives on re-traumatisation, displaced populations and refugee mental health. The final part of this symposium will be an in-depth look at the relationship between Borderline Personality Disorder and CPTSD and implications for treatment.

We are very much looking forward to the conference, and to learning from the fantastic line up of speakers with considerable expertise and knowledge to share.

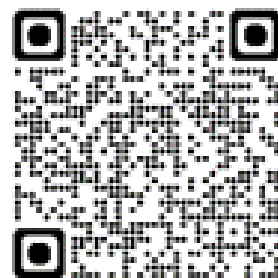


Biography:

Deborah is the director for the Centre for Developmental and Complex Trauma and the course director for the MSc Practitioner in Psychological Trauma and PgDiP Practitioner in Complex Trauma, University of Buckingham. A Consultant Clinical Psychologist by training, Deborah has worked clinically with adults with complex trauma, personality disorder, neurodevelopmental, forensic and mental health needs in the community, assertive outreach, crisis, residential, prison and inpatient settings.

Deborah has previously worked in professional and clinical lead positions and in services to support the mental health and trauma needs of healthcare professionals. Her publications and ongoing research interests include; occupational distress and trauma, treatments for personality disorder, intellectual disabilities, developmental trauma disorders, the intersection between trauma and personality disorder, moral injury, gendered approaches to trauma, adverse childhood experiences, the physical health impact of trauma, and the psychometric properties of psychological tools.

In her spare time Deborah indulges her obsessions with Star Wars, scuba diving with predator sharks and her typically unsuccessful attempts to establish an organic allotment. She is an avid cook and enthusiastically avoids gyms and all forms of organised fitness.

Professor Angela Nickerson **Professor, School of Psychology, University** **of New South Wales, Australia**

Angela Nickerson is Professor and Director of the Refugee Trauma and Recovery Program at the School of Psychology at UNSW, and an Australian National Health and Medical Research Council Investigator Leadership Fellow.



Angela leads a program of research at UNSW that uses longitudinal and experimental methods, as well as randomized controlled trials, to understand factors influencing refugee mental health, and to inform policy and clinical practice. Angela is a clinical psychologist who has worked with refugees in Australia, Switzerland, the US, Timor-Leste and Indonesia. She is Immediate Past President of the International Society for Traumatic Stress Studies.

Dr. Christine Dunkley
Clinical director of Grayrock,
Consultant Psychotherapist, International Trainer,
Author, Researcher.



Christine Dunkley DClinP is a Consultant Psychotherapist, author and international speaker on Dialectical Behaviour Therapy, Mindfulness and Emotional pain. She is a consultant trainer with the British Isles DBT training team. In 2012 she retired from the NHS after 30 years of clinical work and is the Clinical Director of the mental health training company Grayrock.

Christine completed a 4 year degree to qualify as medical social worker in 1982, first working with patients with terminal conditions and their families, then moving into physical trauma. She found her niche in the emergency department working with clients who had self-harmed, which led her to undertake further qualifications in counselling and Dialectical Behaviour Therapy. She gained her doctorate in the University of Southampton school of health sciences on the communication of emotional pain in suicidal clients. She worked for 20 years in the Psychological Therapy Service in Winchester, delivering DBT and Counselling to patients with severe mental health problems. She also supervised in Primary care, developing a placement service for trainee counselors.

In 2006 Christine was invited to join the national DBT training team and began to train and supervise new DBT teams and therapists across the UK and Ireland. She completed training as an adherence coder with staff from the University of Washington and the Linehan Institute. Her specialist subjects are the regulation of painful emotion, and mindfulness.

She has over 30 publications including '[Regulating Emotion the DBT Way](#)', '[Teaching Clients to Use Mindfulness Skills](#)', and '[Using Mindfulness Skills in Everyday Life](#)'. She also co-produced the 'Core Components of Dialectical Behaviour Therapy' DVD series with Michaela Swales. She has provided numerous book chapters and articles for British, American and European Journals.

Christine is Vice President of the Society for DBT and was the first chair. She was awarded a fellowship of the Society in 2016. She has also received a NICE 'shared contributor award' for work relating to developing counselling services in Primary Care. She sat on the national Personality Disorders reference group in University College London, and is an honorary lecturer for Bangor University. She assisted in the treatment development for Radical Openness in the large multi-site NHS RCT.

Síofra is a post-doctoral researcher working on a project about pathways to support for trauma. She completed a BA and MA in Applied Psychology at University College Cork in Ireland before joining King's College London in 2018 to begin her PhD. Prior to this, she worked on the National Rape Crisis Helpline, providing trauma-informed support to survivors of sexual violence.

Her research focuses on improving health care responses to violence, trauma and abuse and completed an ESRC-funded PhD exploring perinatal care experiences among survivors of sexual violence in adulthood. Síofra is also passionate about using creative and artistic ways to conduct research and maximise research impact.

Síofra has led seminars for the Women's Mental Health BSc Psychology module at King's College London. Síofra also worked as an associate lecturer at Birkbeck University of London. for 3 years, leading the 'Developing Child: A Social Perspective' module for the BA Psychology for Education.

Dr Deborah Lee

Dr Deborah Lee is a Consultant Clinical Psychologist, Head of Berkshire Traumatic Stress Service and OPCOURAGE Integrated Services for Veteran Mental Health for the South East of England. Dr Lee has worked in the field of trauma for 33 years and specializes in the treatment of PTSD and Complex PTSD. Her clinical and research interests include working with shame and self-loathing in the context of interpersonal trauma. She has pioneered the development of compassion focused therapy for trauma and complex PTSD and authored the best selling self help book, The Compassionate-Mind Guide to Recovering from Trauma and PTSD: Using Compassion-Focused Therapy to Overcome Flashbacks Shame, Guilt, and Fear (2013). New Harbinger, New York.



Specifically, she is interested in using compassion focused therapy to enhance existing exposure-based trauma memory techniques such as EMDR, prolonged exposure, enhanced reliving, imagery rescripting. More recently she has developed a group-based intervention called 'compassionate resilience' to be delivered as part of phased based treatment approaches for CPTSD. The approach is being used as part of a current RCT treatment trial evaluating phased and non-phased cognitive therapy for CPTSD.

Dr Lee has widely contributed to the dissemination of her clinical programme through writing and, delivering clinical workshops, keynote addresses, podcasts, in North & South America, Europe, Japan and Australia.

Julian Ford, PhD

Professor and Director, Center for Trauma Recovery and Juvenile Justice and Center for the Treatment of Developmental Trauma Disorders, Department of Psychiatry, Farmington CT, USA



Dr. Julian Ford is a board certified clinical psychologist and tenured Professor of Psychiatry of Law where he is Chair on two panels of the Institutional Review Board, and on the faculty of the University of Connecticut School. He is the Principal Investigator and Director of two Treatment and Services Adaptation Centers in the National Child Traumatic Stress Network, the Center for Trauma Recovery and Juvenile Justice and the Center for the Treatment of Developmental Trauma Disorders. He serves as an Associate Editor for the Journal of Trauma and Dissociation and European Journal of Psychotraumatology and as Chair of the American Psychological Association Division of Trauma Psychology Presidential Task Force on Child Trauma. for the American Psychological Association Division of Trauma Psychology. He has served on the International Society for Traumatic Stress Studies Board of Directors and as the Society's Vice President and Secretary.

He has published more than 250 articles and book chapters and am the author or editor of 10 books, including Posttraumatic Stress Disorder, 2nd Edition, Treating Complex Trauma: A Sequenced, Relationship-Based Approach and Treating Complex Traumatic Stress Disorders in Children and Adolescents: Scientific foundations and therapeutic models. He developed and has conducted randomized clinical trial and effectiveness studies with the Trauma Affect Regulation: Guide for Education and Therapy (TARGET©) model for and youth adults with complex PTSD.

Dr Philip Hyland is a Professor in the Department of Psychology at Maynooth University. Philip's research focuses on understanding the nature, predictors, and outcomes of psychological responses to trauma, and the dimensional structure of psychopathology.

Philip is widely published in these areas and currently serves as the Deputy Statistical Editor for the Journal of Traumatic Stress. Philip's research has been funded by several national and international funding agencies including the Health Research Board, the Irish Research Council, and the European Commission.

Dr Edel McGlanaghy is a Clinical Psychologist and Researcher Fellow. Passionate about so much, but specifically trauma informed practice, Complex trauma, perinatal mental health, emotional regulation, EMDR and IPT.

Dr McGlanaghy's current academic focus is on trauma informed access to interventions for Complex trauma, with a strong base in evidence based psychological intervention, meta-analyses & consideration of the adverse effects of psychotherapy.

Professor Marylene Cloitre **Research Professor, NYU Silver School** **of Social Work**



Dr. Marylene Cloitre is a Research Professor and Senior Research Scientist at NYU Silver School of Social Work. Her long-standing research and clinical interests have concerned the long-term effects of psychological trauma on social and emotional functioning. Her current research is dedicated to the development of effective, patient-tailored, flexibly delivered mental health programs for trauma exposed populations.

Dr. Cloitre has received funding for this research from a variety of agencies including NIMH, SAMHSA, PCORI and the VA. She is a member of the advisory board for the planning and ongoing development of the 9/11 Memorial Museum. Dr. Cloitre is past-president of the International Society for Traumatic Stress Studies and was a member of the World Health Organization (WHO) ICD-11 working group on trauma-spectrum disorders. She is also the 2015 recipient of the Award for Outstanding Contributions to the Practice of Trauma Psychology from Division 56 of the American Psychological Association.

Course Structure

The course, taught over six modules covers:

- M1:** Theoretical models informing practice
- M2:** Idiosyncratic assessment and formulation of the whole person impact of trauma and associated needs
- M3:** Idiosyncratic treatment approaches for trauma needs
- M4:** Working with underserved populations
- M5:** Developing trauma informed organisational frameworks, including the assessment of and development of leadership skills.

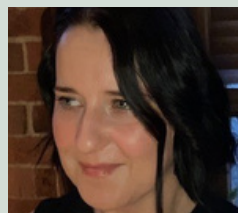

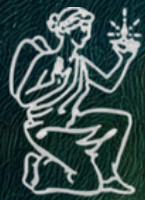

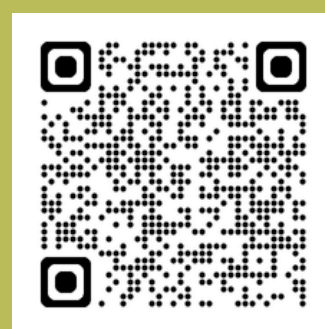
